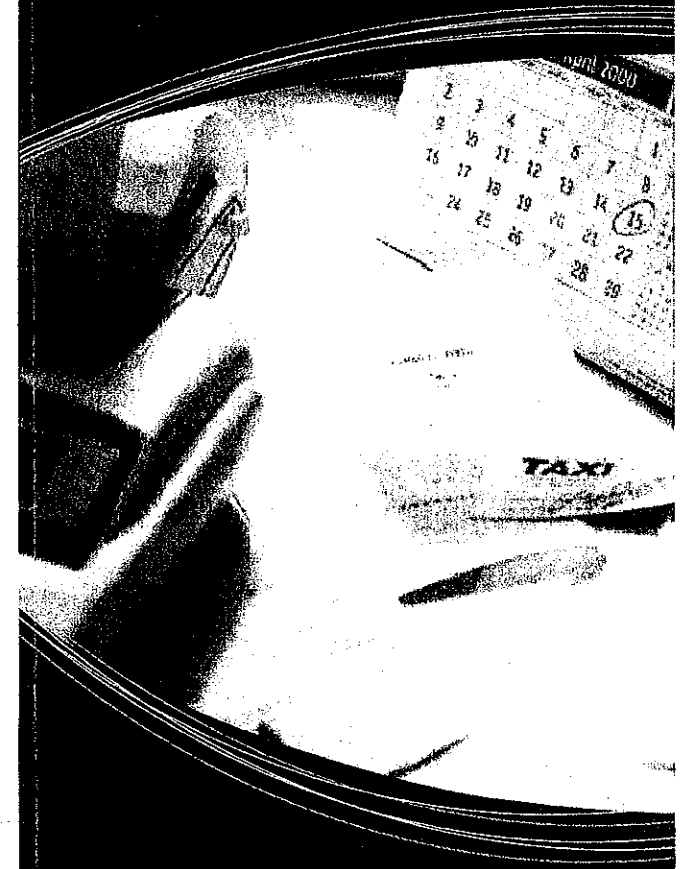

## Pennsylvania Act 32: Changing the way you do payroll !

## Act 32 mandates changes in the way your business does its payroll.

*Under Act 32 all companies doing business in Pennsylvania will be responsible for collecting local Earned Income Taxes from all employees on behalf of the new countywide tax agency.*

**While all residents are welcome, these seminars will be geared to Human Resource and Payroll Departments.**

Under a new law Act 32, Pennsylvania's system for collecting local earned income tax will be streamlined down to 69 new countywide tax collection districts.

Starting January 1, 2012, all Pennsylvania employers (excluding those in Philadelphia) must withhold the local earned income tax as part of their payroll obligations.

Employers are required to file a new quarterly return and remit the amount of tax withheld during the preceding period to the new countywide collector.

### ***Act 32 fundamentally changes your Business' role in collecting local Earned Income Taxes.***

The Allegheny County Southeast Tax Collection Committee selected Keystone Collections Group to serve as their District's new countywide tax collector.

In an effort to educate local employers of their new obligations under the Act, the Allegheny County Southeast Tax Collection Committee and Keystone Collections Group will provide a series of free employer seminars held throughout Southeast Allegheny County.

These free educational sessions are part of an ongoing outreach effort to Southeast Allegheny County employers transitioning to the new system of countywide earned income tax collection and Act 32 compliance.

Keystone representatives will explain the changes mandated by Act 32, the new requirement for employers as well as mandatory withholding and reporting of local earned income tax.
